Dear Judge Glenn:

We represent plaintiff Motors Liquidation Company Avoidance Action Trust ("Plaintiff"). Enclosed as Exhibit A please find the chart that we offered to prepare and submit during closing arguments earlier this week. The chart compares Mr. Goesling's Replacement Cost New Less Depreciation ("RCNLD") with KPMG's RCNLD values for the Representative Assets. As the Court is aware, the values reflected on the chart are before Mr. Goesling's and KPMG's respective adjustments for economic obsolescence.

In addition, during closing arguments, Your Honor asked whether there was evidence in the record about when GM's Asset Recovery Governance Board ("ARGB") was formed. Trial Tr. 3649:16-3650:19. While GM's June 2009 Accounting Policy Manual does not specify the date on which the ARGB was established, it does state that "effective in 2002, Worldwide Purchasing deploys a web-based Asset Recovery System (ARS)," and further describes ARS as "an electronic inventory of available assets for potential reuse within the corporation." JX-0017-0053 (emphasis added); see also id. (effective date for GM Europe's ARGB was June 1, 2001).

Finally, during closing arguments, the Court asked JPMorgan's counsel: "How many of the Fanuc robots at Lansing Delta Township were moved there from other GM manufacturing facilities?" (Trial Tr. 3823:4-16.) On that issue, we respectfully direct the Court to paragraph 891 of Plaintiff's Post-trial Brief, which explains that 75 Fanuc R2000i robots were transferred to Lansing Delta Township between 2009 and 2015 from Orion, Fairfax, Lansing Grand River, Saturn Spring Hill and Grand Blanc Stamping. See also PX-0022C -- Asset #12-0001-0021.
