SUPPLEMENTAL ORDER GRANTING <u>DEBTORS' 148TH OMNIBUS OBJECTION TO CLAIMS</u> (Claims for Equity Interests)

Upon the 148th omnibus objection, dated January 25, 2011 (the "148th Omnibus Objection to Claims") (ECF No. 8821), of Motors Liquidation Company (f/k/a General Motors Corporation) and its affiliated debtors, as debtors in possession (collectively, the "Debtors"), filed pursuant to section 502(b) of title 11, United States Code (the "Bankruptcy Code"), Rule 3007(d) of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules"), seeking entry of an order disallowing the Claims for Equity Interests, and reclassifying those Claims for Equity Interests as equity interests, all as more fully described in the 148th Omnibus Objection to Claims; and due and proper notice of the 148th Omnibus Objection to Claims having been provided, and it appearing that no other or further notice need be provided; and the Court having considered the response to the 148th Omnibus Objection to Claims filed by Patricia Jarunsinski (ECF No. 9817), the reply of the Motors Liquidation Company GUC Trust

("GUC Trust")² to the response (ECF No. 10451), and the failure of the claimant to appear at the hearing on the 148th Omnibus Objection to Claims on July 27, 2011 (the "Hearing"); and the Court having found and determined that the relief sought in the 148th Omnibus Objection to Claims is in the best interests of the Debtors, their estates, creditors, and all parties in interest and that the legal and factual bases set forth in the 148th Omnibus Objection to Claims establish just cause for the relief granted herein; and upon the findings of fact and conclusions of law set forth by this Court at the Hearing; and after due deliberation and sufficient cause appearing therefor, it is hereby

ORDERED that the relief requested in the 148th Omnibus Objection to Claims is granted to the extent provided herein; and it is further

ORDERED that, pursuant to section 502(b) of the Bankruptcy Code, the claims listed on **Exhibit** "A" (the "Order Exhibit") annexed hereto under the heading "Claims to be Reclassified" are disallowed and reclassified as equity interests; and it is further

ORDERED that this Order has no res judicata, estoppel, or other effect on the validity, allowance, or disallowance of, and all rights to object on any basis are expressly reserved with respect to any claim listed on Exhibit "A" annexed to the 148th Omnibus Objection to claims under the heading "Claims to be Reclassified" that is not listed on the Order Exhibit annexed hereto; and it is further

ORDERED that the time for a claimant to seek an appeal from the entry of

this Order shall begin to run from the date this Order is entered as opposed to the date of
