SUPPLEMENTAL ORDER GRANTING 121ST OMNIBUS OBJECTION TO CLAIMS
(Duplicate Debt Claims)

Upon the 121st omnibus objection to claims, dated December 22, 2010 (ECF No. 8267) (the “**121st Omnibus Objection to Claims**”),¹ of Motors Liquidation Company (f/k/a General Motors Corporation) and its affiliated debtors, as debtors in possession (collectively, the “**Debtors**”), filed pursuant to section 502(b) of title 11, United States Code (the “**Bankruptcy Code**”), Rule 3007(d) of the Federal Rules of Bankruptcy Procedure (the “**Bankruptcy Rules**”), and this Court’s supplemental order establishing supplemental rules and authority for filing omnibus objections to certain debt claims (the “**Supplemental Procedures Order**”) (ECF No. 6238), seeking entry of an order disallowing and expunging the Duplicate Debt Claims on the grounds that such claims are duplicative, all as more fully described in the 121st Omnibus Objection to Claims; and due and proper notice of the 121st Omnibus Objection to Claims having been provided, and it appearing that no other or further notice need be provided; and Nicholas Martin having made an informal response to the 121st Omnibus Objection to Claims and the GUC Trust having filed a reply (ECF No. 11134); and hearing on the 121st Omnibus

Objection to Claims having been held on November 22, 2011 (the “**Hearing**”); and the Court having found and determined that the relief sought in the 121st Omnibus Objection to Claims is in the best interests of the Debtors, their estates, creditors, and all parties in interest and that the legal and factual bases set forth in the 121st Omnibus Objection to Claims establish just cause for the relief granted herein; and after due deliberation and sufficient cause appearing therefor, based on the findings of fact and conclusions of law set forth by the Court at the Hearing, it is hereby

ORDERED that the relief requested in the 121st Omnibus Objection to Claims is granted to the extent provided herein; and it is further

ORDERED that, pursuant to section 502(b) of the Bankruptcy Code, Claim Number 3915 filed by Nicholas Martin is disallowed and expunged; and it is further

ORDERED that this Court shall retain jurisdiction to hear and determine all matters arising from or related to this Order.
