**PLEASE TAKE NOTICE THAT** on March 29, 2011, the Bankruptcy Court for the Southern District of New York entered an Order confirming the Debtors’ Second Amended Joint Chapter 11 Plan, dated March 18, 2011 (ECF No. 9941) (as may be amended, supplemented, or modified from time to time, the “**Plan**”),<sup>1</sup> filed by Motors Liquidation Company (f/k/a General Motors Corporation) and its affiliated debtors (collectively, the “**Debtors**”), and the Plan became effective on March 31, 2011.

**PLEASE TAKE FURTHER NOTICE THAT** the Motors Liquidation Company GUC Trust (the “**GUC Trust**”)<sup>2</sup> has determined that the above-referenced claim filed against the Debtors constitutes a Class 5 Asbestos Personal Injury Claim under the Plan, rather than, a Class 3 General Unsecured Claim.
