expunged from the claims registry; and it is further

the validity, allowance, or disallowance of, and all rights to object on any basis are

expressly reserved with respect to, any claim listed on Exhibit "A" annexed to the 240th

Omnibus Objection to Claims under the heading "Claims to be Disallowed and

Expunged" that is not disallowed or expunged pursuant to this Order; and it is further

ORDERED that this Court shall retain jurisdiction to hear and determine

all matters arising from or related to this Order.
