**STIPULATION AND [PROPOSED] ORDER AMENDING AND SUPPLEMENTING
PRIOR ORDER REGARDING DISCOVERY AND SCHEDULING [ECF 153]**

WHEREAS, for the Court's convenience and in the interests of finality and efficiency, and in order to resolve at the same time certain Rule 12 motions already filed or to be filed by multiple parties, the undersigned parties have agreed on certain deadlines, set forth below, for (1) Defendant JPMorgan Chase Bank, N.A. ("JPM") to answer or move under Rule 12(b) with respect to the cross-claims filed against it, (2) the Plaintiff to move under Rule 12 with respect to the current pleadings, (3) Defendants who have not already filed Rule 12(b) motions with respect to service extensions to file Rule 12(c) motions raising service extension issues related to those raised in the Rule 12(b) motions already on file, preserving their rights to file later Rule 12(c) motions addressing any other issues, and (4) briefing and resolution of already-pending Rule 12(b) motions (ECF 226, ECF 262, and ECF 311), and the motions that join one or both of those motions (ECF 237, ECF 275, ECF 276, ECF 281, ECF 287, ECF 293, and ECF 308), as well as briefing and resolution of motions to quash or to dismiss previously filed on behalf of certain non-parties (ECF 240, ECF 267, and ECF 270);

WHEREAS, in order to coordinate the briefing and resolution of the parties' various filings, the parties also have agreed to amend certain deadlines previously set forth in the Court's Order Regarding Discovery and Scheduling (ECF 153 ("Prior Scheduling Order")), as may have been amended by agreement of the parties);

IT IS HEREBY STIPULATED [AND ORDERED] as follows:

1. Amended and Supplemented Scheduling Order: The Prior Scheduling Order shall be amended and supplemented as follows:

Jan. 27, 2016 Defendants' deadline to move under Rule 12(c) with respect to service extension-related issues raised in ECF 226 and ECF 262; JPM's deadline to answer or move under Rule 12(b) with respect to the cross-claims filed against it; Plaintiff's deadline to move under Rule 12 with respect to the current pleadings

Mar. 4, 2016 Plaintiff's deadline to respond to the aforementioned Rule 12 motions filed by Defendants and to motions filed by non-parties on or before Jan. 20, 2016, including previously-filed motions ECF 240, ECF 267, ECF 270, ECF 226, ECF 262, and ECF 311 and the motions that join one or more of those motions; Defendants' deadline to respond to any Rule 12 motion filed by the Plaintiff and/or by JPM

Mar. 30, 2016 Defendants' and Plaintiff's deadline to file replies on any motions, as applicable

No other deadline set forth in the Prior Scheduling Order is altered by this Stipulation and Order.

2. Reservation of Right to File Further Rule 12(c) Motions: The inclusion of service extension-related Rule 12(c) motions in the above schedule shall not affect the right of any party to file further Rule 12(c) motions with respect to unrelated issues, including non-service extension-related issues raised in the existing Rules 12 motions and joinders.

3. Further Adjustments to Schedule: Each party reserves its right to apply to the Court to alter any of the deadlines herein or in the Prior Scheduling Order, and each party reserves its right to oppose any such application.

4. Hearing: The parties propose that the Court set the above motions for hearing on the same date.
