Stasko (the Creditor) for an order, pursuant to section 362(d) of title 11 of the United States Code (the “Bankruptcy Code”) vacating the automatic stay imposed in the above-captioned case by section 362(a) of the Bankruptcy Code as to the Creditor’s interests in 767 Fifth Avenue New York, New York 10153 (the “Property”; the location of Principal Assets of Business Debtor) to allow the Creditor’s enforcement of its rights in, and remedies in and to, the Property.
