**STIPULATION AND ORDER EXTENDING TIME TO
RESPOND TO FIRST AMENDED ADVERSARY COMPLAINT**

WHEREAS, on April 26, 2016, the Plaintiff filed an application for certificate of default against several defendants in the above-captioned adversary proceeding (the “Action”), including against Lehman Principal Investors Fund, Inc. – High Yield Fund [Adv. Proc. Docket No. 503];

WHEREAS, on May 3, 2016, the Clerk of the Court granted the Plaintiff’s application for a certificate of default against Lehman Principal Investors Fund, Inc. – High Yield Fund [Adv. Proc. Docket No. 513] (the “Certificate of Default”);

WHEREAS, the correct name of Lehman Principal Investors Fund, Inc. – High Yield Fund is “High Yield Fund I, a series of Principal Funds, Inc.”; and

WHEREAS, the Plaintiff and High Yield Fund I, a series of Principal Funds, Inc. agree that the Certificate of Default should be vacated;

IT IS HEREBY ORDERED AS FOLLOWS:

1. The Certificate of Default is vacated as to Lehman Principal Investors Fund, Inc. – High Yield Fund.

2. The date by which High Yield Fund I, a series of Principal Funds, Inc. must answer the *First Amended Adversary Complaint for (1) Avoidance of Unperfected Lien, (2) Avoidance and Recovery of Postpetition Transfers, (3) Avoidance and Recovery of Preferential Payments, and (4) Disallowance of Claims by Defendants* [Adv. Proc. Docket No. 91] in the Action is hereby extended to thirty days following the Court’s entry of this order.
