

A creditor is any person, corporation or other entity to which the debtor owes a debt.

**Proof of Claim**  
A form filed with the clerk of the bankruptcy court where the bankruptcy case was filed, to tell the bankruptcy court how much the debtor owes a creditor (the amount of the creditor's claim).

**ITEMS TO BE COMPLETED ON THIS WITHDRAWAL OF CLAIM**

**Court, Name of Debtor and Case Number:**  
Fill in the name of the federal judicial district where the bankruptcy case was filed (for example, Central District of California), the name of the debtor in the bankruptcy case, and the bankruptcy case number. If you received a notice of the case from the court, fill in the information on a card on top of the notice.

**Information about Creditor:**  
Complete the section from the notice of address of the creditor that was filed with the court with the Proof of Claim form name.

**Information identifying the Claim that is to be withdrawn:**  
Complete the section from the notice of address of the creditor that was filed with the court with the Proof of Claim form name.

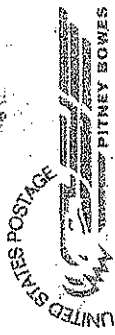
Sign and print the name and title, if any, of the creditor or other person authorized to file this withdrawal of claim under a copy of power of attorney, if any.

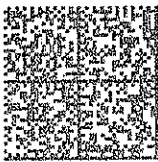

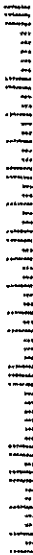
