ORDER PURSUANT TO 11 U.S.C. § 365 AUTHORIZING THE DEBTORS TO ASSUME AND ASSIGN CERTAIN CONTRACTS TO THE ENVIRONMENTAL RESPONSE TRUST CONDITIONED ON AND AS OF THE EFFECTIVE DATE

Upon the Motion, dated February 17, 2011 (the "Motion"), of Motors
Liquidation Company (f/k/a General Motors Corporation) and its affiliated debtors, as debtors in possession (collectively, the "Debtors"), for an order authorizing the Debtors to assume and assign certain contracts to the Environmental Response Trust, on and as of the effective date of the Plan, pursuant to section 365 of title 11, United States Code (the "Bankruptcy Code"), and Rule 6004 of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules"), all as more fully described in the Motion; and due and proper notice of the Motion having been provided, and it appearing that no other or further notice need be provided; and it appearing that no objections were filed with respect to the Motion; and the Court having found and determined that the relief sought in the Motion is in the best interests of the Debtors, their estates, creditors, and all parties in interest and that the legal and factual bases set forth in the Motion establish just cause for the relief granted herein; and after due deliberation and sufficient cause appearing therefor, it is

ORDERED that the Motion is granted as provided herein; and it is further

ORDERED that the requirements set forth in Bankruptcy Rule 6004(a) are hereby

waived; and it is further

ORDERED that pursuant to Bankruptcy Rule 6004(h), the terms and provisions

of the Order shall be immediately effective and enforceable upon its entry; and it is further

ORDERED that pursuant to sections 365(a), (b) and (f) of the Bankruptcy Code,

the Debtors are hereby authorized to assume the Contracts listed on the annexed Exhibit A, and

assign them to the ERT, on and as of the effective date of the Plan; and it is further

ORDERED that in the absence of an objection to the cure amounts set forth on

Exhibit A, each counterparty to a Contract shall be barred from asserting a claim for any

defaults arising prior to the effective date of assumption; and it is further

ORDERED that this Court shall retain jurisdiction to hear and determine all

matters arising from or related to this Order.
